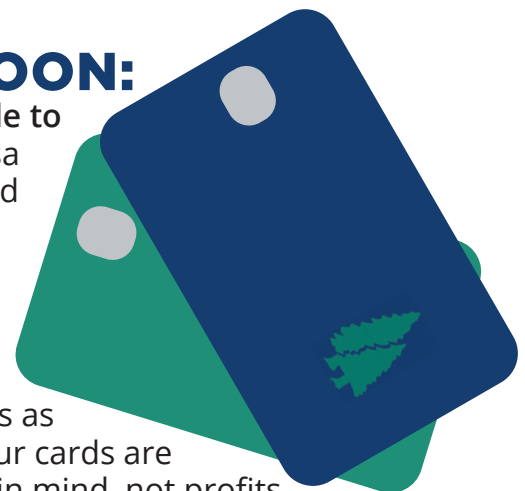
## Traveling this summer?

## COMING SOON:

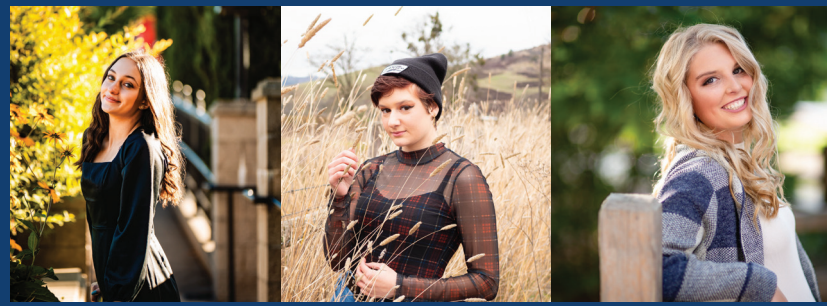
Soon you will be able to apply for a CCCU Visa and receive your card the same day at our Garden Valley and Harvard branches.

## POLICY UPDATES

### Consumer Membership Agreement

Effective August 1, 2021

#### Existing Section

##### 4. POD Designations

A Payable on Death (POD) designation is an instruction to the Credit Union that a designated account is an account payable to the owner or owners during their lifetimes, and upon the death of the last joint account owner, payable to any named and surviving POD beneficiary designated by you. Accounts payable to more than one POD beneficiary are owned jointly by such beneficiaries **without** rights of survivorship. Any POD beneficiary designation shall not apply to IRA accounts which shall be governed by a separate beneficiary designation. The Credit Union shall at no time have any obligation to notify any beneficiary of the existence of any account or the vesting of the beneficiary's interest in any account, except as otherwise provided by law.

#### Revised Section

##### 4. POD Designations
