### **POLICY UPDATES**

Effective July 1, 2023

1. Mobile Deposit Service Agreement Under Section 1.2, Funds Availability:

#### 1.2 Funds Availability

•We require review, during business hours, before posting to your account and before we make the funds available, for each of your first few items when first using the Service, and each item of \$2500 \$3500 or more.

•For items less than \$2500 \$3500, after the first few initial items, and during the period when an account has been open for 90 60 calendar days or fewer the first \$225 per calendar day of all deposits made thru the Service will normally be available to you immediately when we receive deposit(s). The balance of all deposits made thru the Service exceeding the immediately available (\$225) amount per calendar day will normally be made available to you not later than 9am (Pacific Time Zone in Roseburg OR) on the second business day after we have received the deposit(s).

•For items less than \$2500-\$3500, and after the first few initial items, and when the account has been open for more than 90 60 calendar days, the first \$1000 per calendar day of all deposits made thru the Service will normally be available to you immediately when we receive the deposit(s). The balance of all deposits made thru the Service exceeding the immediately available (\$1000) amount above per calendar day will normally be made available to you not later than 9am (Pacific Time Zone in Roseburg OR) on the first business day after we have received the deposit(s).

#### 1.3 Deposit Limitations

You agree you will not use the Service to make deposits exceeding twenty (20) items in any calendar month. Additionally, the Service is set by us to impose per item, per day, and per rolling thirty-day (30 day) limits of \$2500 \$3500 or more, determined in our sole discretion

## 1. Cascade Community Credit Union Fee Schedule:

The following fees will be removed from our rate and fee schedule and no longer be charged.

- -Check copy fee

- -Wire Transfer (Incoming)
